

FY 2024-2026 VHSP Competition – Collaborative Application Timeline

The Harrisonburg Redevelopment and Housing Authority (HRHA) is the Lead Agency and fiscal agent for the Western Virginia Continuum of Care (CoC) and is responsible for coordinating the preparation and submission of the biennial CoC Collaborative Application to the Virginia Department of Housing and Community Development (DHCD) for its Virginia Homeless Solution Program funding competition. The CoC anticipates that DHCD will release the FY 2024-2026 Notice of Funding Opportunity (NOFO) in the upcoming weeks, by which time further details on the proposal process will be provided.

Agencies intending to apply for **Street Outreach**, **Prevention**, **or Rapid Rehousing** projects to serve **Winchester**, **Frederick and Clarke Counties** must submit a duly completed letter of intent to the CoC indicating the project (s) type, contact person for the application process along with other requested information. *All letter of intent must be received by no later than: COB Friday, January 26, 2024*

Please note that this timeline will be updated with new activities upon release of the NOFO by DHCD.

Application Preparation:	
Organization interested in submitting a new project application under the CoC will	
need to:	
 Maintain the necessary Unique Entity Identifier (UEI) as assigned by the System for Award Management (SAM) to uniquely identify a business. Please note that the Federal government has transitioned from the use of DUNS number to UEI as of April 4, 2022. Visit www.sam.gov/SAM to complete registration, or by calling (877)252-2700. Registration steps can also be found here. The process for obtaining a UEI can take up to two business days. Register in DHCD's Centralized Application and Management System (CAMS) and submit one of the following financial documents: Financial Statement Audited Financial Statement; or an OMB A-122 Audit (Single Audit). All financial documents must be prepared by an independent Certified Public Accountant (CPA). A full DHCD's financial policy can be reviewed at this link. 	Plan for 2 to 3 business days for UEI.

 Notice of Project Acceptance/Rejection Conclusion of ad-hoc process for selection of new grantee. All applicants will be notified via email about the acceptance of their eligibility to participate in the CoC's VHSP collaborative funding process.
